Shipper / Ark Foods carries separate documentation detailing the value of this load. In the event of a loss, logistics company / freight broker agrees that the declared value of the load is the delivered price of the full order, which Ark Foods will provide in the form of a purchase order (PO) or invoice. Driver must check count and temperature at the time of loading. Any shortages or out of range temperatures must be reported prior to leaving the shipper's dock. Make sure the load is braced and suitable for transport. Any shortages or damaged cases at delivery will be deducted from the freight invoice. If a temperature recorder is assigned to the BOL it will be presumed that that it is in the trailer and must be delivered to the consignee. Trailers are required to have a seal or padlock at all times. All product must remain on pallets; no floor stacking. If the consignee rejects any item or makes any notations on the BOL, it must be reported before you pull away from the Receiver's dock. If this is a full load (FTL) carrier must report the truck's location and ETA to destination by 9AM each day or be fined \$100 per incident. If this is an LTL shipment, carrier must report any delays in making a normal delivery or missing a scheduled delivery appointment in advance.
