- 2. Price and Payment.** Prices are firm and not subject to change without Buyer's written approval. Invoices must reference this PO number and be sent to billing@arkfoods.com. Unless otherwise stated, payment terms are **Net 30 days** from receipt of invoice and conforming goods.
- 3. Delivery and Inspection.** Time is of the essence. Buyer may inspect and reject goods that fail to meet specifications, quality, or timing requirements. Title and risk of loss pass to Buyer only upon **delivery and acceptance** at the "Ship To" address listed on this PO.
- 4. Produce Purchases (PACA).** All purchases of fresh or perishable produce are subject to the **Perishable Agricultural Commodities Act (PACA)**, including the standard inspection, acceptance, and prompt payment provisions under **7 U.S.C. §499e(c)**. Unless otherwise noted, produce must meet or exceed **USDA No. 1 grade and condition** standards at time of receipt. Buyer retains all rights afforded under PACA.
- 5. Seed Purchases.** Seller warrants that all seed provided is true to name, variety, and lot number, and compliant with all applicable **USDA and state seed laws**. Buyer may return or reject seed that fails germination or purity tests.
- 6. Packaging Purchases.** All packaging must meet Buyer's approved **specifications for material, size, and print**, and be suitable for direct food contact where applicable. Supplier assumes responsibility for any nonconforming or mislabeled materials.
- 7. Compliance.** Seller warrants that all goods comply with **all applicable federal, state, and local laws**, including but not limited to labor, environmental, labeling, and food safety regulations.
